- b. Capitol update: A. Cazal provided an update. Part 115 was not taken up today in House Ways and Means Committee. Session and committee meetings were cancelled. Session is scheduled for next Wednesday. There are 9 session days left in 2020. House committee is working on some technical amendments to the package. He has met with Senate leadership staff to discuss Part 115. There is no update on the host community definition for the Northville amendment.

## VIII. Technical Standards Committee Report

a. E. Shafer, committee chair, provided a summary of activities. A committee meeting was held this morning. Air Quality division is setting up stakeholder workgroups to discuss ways to decrease ozone levels, formaldehyde from landfill flairs, and methane emissions. He will circulate additional information via email. TENORM reporting is expected to be submitted in the future using a platform other than the waste receipt report system. The MWRA/MWEA/MPART/EGLE meetings are focused on PFOA/PFOS and related compliance issues. Texas Tech is looking for volunteers to provide leachate samples. University researchers are studying how much liner systems restrict flow of PFAS. He will distribute a PowerPoint that details the study. A number of EGLE department retirements are expected this year.
